'SHISHA OFF' OBJECT NOW!

In our last In Touch, we reported about the new shisha bar "Monte Cristo" which has opened at 56-58 Fortune Green Road without planning permission.

Following a number of complaints, the Council wrote to the owner requiring an application for planning permission to be put in. A planning application for the existing use was put in on Friday 11th April.

You have the right to have your say on the plans. If you have been affected by the opening of the shisha bar, it is important to write into the Council to comment on the planning application. In particular:

- 1. The shisha bar is inappropriate in a residential area. There are flats above the bar and family properties in nearby Burrard Road, Achilles Road, Ajax Road, and Ulysses Road.
- 2. There are a large number of outside seats which is encouraging large groups of customers to gather together and cause noise and disturbance to the neighbourhood into the early hours of the morning.
- 3. Parking is becoming even more difficult, as the nearby roads are all de-restricted in the evenings. This is already a serious problem as it is, but the shisha bar is making the problem even worse.

Parking survey

■ As many of you will be aware, Camden Council has published the results of the parking survey which took place last autumn.

The report noted that Achilles Road, Ulysses Road and Aldred Road returned higher numbers in favour of extended hours of control during the week. However, whilst it "recognised that those who desire longer hours feel very strongly on the issue" it concluded that this should not happen "based on the context of majority opposition to change from the wider coherent area." As a result of this decision, it is even more important that action is taken to stop the illegal use of existing parking spaces, that inappropriate planning applications likely to increase parking and traffic problems are refused and that the Council reviews the existing provision of vellow lines.
